QUOTATION / SALES CONTRACT

All marbles, granites and natural stones are products of nature and as such, may have small cracks, blemishes, voids and inconsistencies, which are inherent properties in stone, and are not considered defects. Variations in colour, shade, surface, texture and slab thickness are also common in marbles and granites.

Once a stone has been selected, Granite Valley Stone Company Ltd. will make every attempt to provide a product that relates to the product initially selected or specified to provide consistency and matching colour, but cannot guarantee an identical colour match.

Our policy on slab selection may restrict customers from selecting a specific slab within a bundle. Location of cuts and joints will be at the discretion of Granite Valley Stone Company Ltd.

Installations by Granite Valley Stone Company Ltd will require all new cabinets to be installed completely, old countertops remove from existing cabinets and the site made ready to receive new countertops.

Once this sales contract has been accepted, Granite Valley Stone Company Ltd will request access to the site for measuring. At this time, you, the customer, must provide absolutely, all detail specifications, sink type, cook-top and tap information to avoid additional site visits, which would then be charged to your account. Site measuring will take place when all cabinets are in place and above information is at hand. We request that the customer and contractor be present during site measurements to avoid any misunderstanding of details.

Delivery / completion date is based on all pertinent information being provided to Granite Valley Stone Company Ltd. Any delays in providing all pertinent information will result in delays in completion. Delivery is subject to availability of specified material at the time of acceptance.

During installation, marble and granite dust may be present. Granite Valley Stone Company Ltd will try to minimize the amount of dust, but will not be liable for any clean-up costs.

Granite Valley Stone Company Ltd does not supply a delivery service unless Granite Valley Stone Company Ltd performs the installation. Installation does not include under-mounting of sinks unless quoted. Where installation is not quoted by Granite Valley Stone Company Ltd, customers are solely responsible for pick-up of their own fabricated material and must provide their own A-frames, packing materials, ropes, straps, etc to transport purchased stone.

A 50% non-refundable deposit must be received before proceeding with the order. Final payment is due upon installation of the order.

This Quotation / Sales Contract is based on information that has been provided to Granite Valley Stone Company Ltd. Any changes to specifications, details, sizes or colours after acceptance may result in additional cost and delay in completion.

Notes: This contract must be signed, dated and accompanied by a nonrefundable deposit payable to Granite Valley Stone Company Ltd before your order will be processed.
